TOWN OF LELAND RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

I understand that participating in the recreational program selected involves risk of injury. These risks include inclement weather, accidents while traveling, equipment problems or failures, contacts with and actions of other participants, slips/trips/falls, and musculoskeletal injuries, among others. I choose for myself or for my child to participate in the selected programs despite the risks. By registering for a program, I acknowledge all risks of injury, illness, and death and affirm that I have assumed all responsibility of injury, illness, or death in any way connected with participation in the program. I also agree for myself and for any child participant to follow all rules and procedures of the program and to follow the reasonable instructions of the teachers and supervisors of the program. In return for the opportunity to participate in this program, I agree for myself and for my heirs, assigns, executors, and administrators to release, waive, and discharge any legal rights I may have to seek payment or relief of any kind from the Town of Leland, its employees/volunteers or its agents for injury, illness, or death resulting from this program. If I am registering a child for a program, I agree that I am a parent, legal guardian, or am otherwise responsible for the child whom I am registering and that I release, waive, and discharge any legal rights that I may assert on behalf of the child participation in the program. I also agree not to sue the Town of Leland, its employees/volunteers, or its agents and agree to indemnify the Town of Leland for all claims, damages, losses, or expenses, including attorney's fees, if a suit is filed concerning an injury, illness, or death to me or to my child resulting from participation in the program

LCAC Refund Policy

REFUND POLICY

- All refund requests received 14 days or more in advance of the start date of the program are entitled to a 100% refund, less the online ActiveNet processing fee.
- If the LCAC cancels a program participants are entitled to a 100% refund, less the online ActiveNet processing fee.
- Refunds for medical/emergency reasons requested within 14 days of the start date of the program will be granted on a case by case basis.
- Refunds can be processed back to the credit card used for the transaction, by check, by account credit, or transferring to another course. An account credit does not expire and may be used by any individual on the same registration account. To use an account credit, participants must call or visit or the LCAC. Please allow 2-3 weeks for refunds processed back to a credit card or by check.
- Non-attendance/non-participation in a program does not entitle a participant to a refund.
- The LCAC will determine if a program will be running approximately 3-4 days prior to the start date of the program. The LCAC does not contact participants if a program is running.
- For class cancellations and inclement weather, participants will be contacted by the LCAC/instructor via phone or email. The LCAC/instructor will put forth all effort to contact each participant. When possible, the Town of Leland will also update social media and news outlets regarding closures during inclement weather.
