The Artist in Residence program is open to both 2D and 3D artist(s). The goal of this program is to provide an outlet for both emerging and established artists to grow and refine their craft and share their knowledge and skills with the community.

**Submission Deadline for the 2023 Artist in Residence program is Friday, April 7, 2023.**

## **Eligibility**

Artists 18 years of age and older residing in Leland, Brunswick County, and surrounding areas are eligible. All North Carolina artists may apply; however, regular access to the LCAC is essential.

## **Selection**

1. Artists will be selected from an application process that will include a review of work samples, resume, and teaching experience.
2. After selection, LCAC will contact chosen artists and include contracts and work to establish teaching and exhibition schedule.
3. Artists not chosen will be contacted via email.

## **Description of Artist in Residence Program**

Artists in Residence will have access to the LCAC's open studio spaces on a daily basis (per class schedule availability) to work on personal projects and build a body of work while also interacting with community members and students participating in programs. At the end of the residency, artists will have the opportunity to showcase their work in a month-long exhibit in the LCAC's gallery space. Beyond having space to work and exhibit, Artists will teach at least one youth and/or one adult program in their area of focus during the Spring and Summer 2023 program sessions as well as participate in community events organized by the Town of Leland.

## **Compensation**

Artists will be compensated for teaching at a flat per-program rate as outlined in the instructor agreement. Flat rate ranges are \$200 - \$600, based on the agreed upon teaching schedule.
